8. LIBRARY DIRECTOR REPORT - Deb Rutter

- a. Ms. Rutter reported that a new director of the Cheshire Public Library is Ms.Beth Crowley, who comes from the Madison Public Library.
- b. The renovations are continuing, with new restrooms in the basement section and four private room. There will be a new art display section.
- c. The new children's librarian is Ms. Emily DePaolo.

9. ARTSPLACE REPORT – Ms. Joan Pilarczyk

- a. Marian Gansley has been hired for a five hour a week position.
- b. All furniture was moved and the floor cleaned and waxed in August.
- c. There is a Colored Pencil exhibit currently on view at the Cheshire Public Library.
- d. Ms. Pilarczyk thanked committee members for assisting Artsplace at the 2nd Annual Ball & Socket Arts Fair, held on Sunday, September 9th. It coincided with the Ribbon Cutting of the Rails to Trails section that runs by the Ball and Socket Arts building. Members did face painting and shell painting activity for children from 10:00 am to 12:00 pm.
- e. The Summer Session finished with 175 students taking part in 40 classes and workshops.
- f. Artist Patti Mollica gave a free to the public talk about acrylic paints on Thursday September 13th, with 40 people in attendance. Ms. Mollica conducted an informative three day workshop for students from several states, Friday September 14th to Sunday, September 16th. The Friends group kindly provided breakfast items and coffee and tea.
- g. The Fall session currently has 245 students enrolled in 26 classes and workshops. Winter and Spring classes are being scheduled.
- h. An organizational meeting for the Art Market was held on Tuesday, September 11th. The *Third Annual Art Market* will take place November 17th to 18th from 10:00 am to 4:00 pm on both days. Ms. Rita Paradis is the chairperson of the event. Over 26 local artists will be selling their artwork to the public. More information will be forthcoming. It was requested that Library pages be utilized as greeters.
- i. Artsplace is waiting to find out about its presence in the *Cheshire Welcome Wagon* booklet for new residents, coordinated by Ms. Kathleen Moore.
- j. October 19th from 5:00 to 8:30 there will be a joint event between Artsplace and Cheshire Parks and Recreation held at Mixville. The first hour children will be able to carve pumpkins that they bring. All cutting materials will be provided. Afterwards a family film will be shown.
- k. Ms. Pilarczyk reported that she read the Kensett book on film at Cox communications in Cheshire. St. Bridget School requested 31 books for it's 3rd grade. A reprinting is needed.
- l. There will be a John Frederick Kensett Birthday Celebration held at the Cheshire Public Library on March 22, 2019 from 3pm to 5pm.

- a. The Improv Night held at Artsplace was a fun night and open to the public.
