Ricciardi Builders, LLC acting on behalf of Brian Rogers
Replacement of Handicap Ramp

Mr. Sitko stated there were no communications with regard to this application, except one email from Joe Ricciardi, the builder, indicating the railings will be made from white vinyl, classic style with 4" on center 2"x2" balusters, resembling a classic wooden railing. Mr. Rogers said the existing ramp is a monstrosity and the goal is to make it smaller, more streamlined and more attractive. Mr. Dattilo stated the application indicates the railings will be made of a fiberglass material which will add texture. There was a discussion about the railings and whether the new ramp will be attached to the building. Mr. Rogers was unable to answer some of the questions from the commissioners and stated he will contact the builder, who was not able to attend the meeting.
